# Abdul HANNAN – Bangladesh

Career diplomat Abdul Hannan, after more than three and a half decades of diplomatic and government services, retired in 2017. He served as High Commissioner of Bangladesh in the United Kingdom (2014-2016) and was concurrently accredited Ambassador to Ireland. Furthermore, he represented Bangladesh in The Commonwealth, & International Maritime Organization (IMO). Before this, Ambassador Hannan served as Ambassador & Permanent Representative to the UN in Geneva & Vienna, and numerous other international organisations including the World Trade Organisation (WTO), Conference on Disarmament (CD), and IOM. From Geneva, he was concurrently represented as Ambassador to Switzerland and The Holy See

(Vatican). From 2006-2009 he was Ambassador to Oman. In the Ministry of Foreign Affairs, Ambassador Hannan served as Director General and Vice Principal of the Foreign Service Academy; Director (Europe); Director (SAARC); Director, Prime Minister's Office; and Assistant Secretary, attached to Foreign Minister's Office.

During Missions abroad, he served as Minister and Deputy Chief of Mission in Ottawa; Deputy High Commissioner in Karachi, Pakistan; Counsellor (Political) in Kolkata, India; and First Secretary (Political) in Moscow. Ambassador Hannan started his diplomatic career in 1986, before which he served as Assistant Commissioner and Magistrate, as member of Bangladesh Civil Service (Administration) Cadre in 1983, and Research and Planning Officer in the Ministry of Labour, Manpower and Social Affairs (1981-1983).

After retirement (2017), Ambassador Hannan was a consultant to the World Intellectual Property Organization (2017-2018) and Adviser to the Federation of Chambers of Commerce and Industries (FBCCI) – apex trade body in Bangladesh (2020). From 2019-2022, he was Adviser to the United Nations' Central Emergency Response Fund Advisory Group (UN CERF-AG).

Alan stepped down from the Foundation in 2020, but continues to support international efforts to promote peace and development as Chair of the Advisory Board of the Peace Division of UNITAR and as a member of the board of INTERPEACE, the Geneva-based peacebuilding organisation. In 2021 he published, *A Peacekeeper in Africa: Learning from UN Interventions in other People's Wars*, which The Financial Times described as "a vivid personal memoir, and a deeply informed reflection on the international community's role in ending deadly conflicts in Africa."

As a member of both the Law Society of Ontario, Canada, as well as the New York Bar, he has practiced private international law with law firm Stikeman Elliot, and as Law and Policy Adviser to the CEO of the University of British Columbia's Liu Institute for Global Initiative.

Earlier in her career, she served as Registrar of the Supreme Court and Registrar of Companies in the British Virgin Islands, with additional responsibilities as Magistrate, Supervisor of Elections, and Admiralty Marshall. She is fluent in English and French and has a long-standing commitment to adolescent rights, gender equality, and humanitarian protection.

A professional diplomat, Antonio Armellini was roving Ambassador to the CSCE (Conference on Security and Cooperation in Europe), from 1990-92, Deputy Ambassador in London in 1992-98, Ambassador to Algeria in 1998-2000, Ambassador-at-large for International Anti-Terrorism in 2001-02, Ambassador-at-large and Special Envoy to Iraq in 2003-04, Ambassador to India and Nepal in 2004-08, and Ambassador to the OECD (Paris) in 2008-10. Other foreign postings include Brussels, Warsaw, Addis Ababa, Vienna, Helsinki; he was Spokesman for European Commissioner Altiero Spinelli in 1972-74 and served as Assistant Private Secretary to Foreign Minister and Prime Minister Aldo Moro, in 1969-72 and 1974-75.

He served as Director of SAVE Spa (airport of Venice) in 1986-89, Director of BIIS Bank in 2010-12, Director of Thetis Spa in 2010-13. He was special advisor to the Mayor of Venice in 2011-2014 and Commissioner of IsIAO, Italian Institute for Africa and the Orient, in 2011-2016.

With a professional background in European affairs and international security, his interests include the geo-politics of the Asian region and multilateral economic cooperation, on which he has written and lectured extensively. He was visiting lecturer in comparative politics at LUISS University in Rome in 2003-04, and in comparative international relations at "Ca' Foscari" University in Venice, in 2008-09. He is a member of the International Institute for Strategic Studies (IISS) in London, Istituto Affari Internazionali (IAI) in Rome, Aspen Institute Italia in Rome, Centro Studi Politica Internazionale (CESPI) in Rome, Official Monetary and Financial Institutions Forum (OMFIF) in London, amongst others.

He is an editorialist with Il Corriere della Sera in Milan and a regular contributor to The Huffington Post Italy and various journals on international affairs. Recent books include: *l'Elefante ha Messo le Ali*, on contemporary India, (Bocconi University Press, 2008, 2013) published in English as *If the Elephant Flies* (Har Anand Press, 2012); *Né Centauro né Chimera – Modesta Proposta per una Europa Plurale* with Gerardo Mombelli (Marsilio Editori, 2016); *L'Italia e la Carta di Parigi per una Nuova Europa della CSCE* (Editoriale Scientifica, 2022).

Ambassador Tunde O. #### **Bo GORANSSON** – Sweden

Bo Goransson has held multiple positions in the development sphere in a number of countries. A graduate from the Stockholm School of Economics, he initially worked for a management consultancy firm, charged with reorganizing the water supply in Riyadh, Saudi Arabia, followed by a long-term assignment in the Sudan, restructuring their large rural water operations.

He then joined Sida, the Swedish International Development cooperation Agency, and was responsible for its programme in Tanzania in 1974-77, based in Dar es Salaam. He worked at the Ministry of Agriculture in Ethiopia from 1986 to 1988, with soil conservation, forestry and land rehabilitation in famine-

stricken Welo. He left Ethiopia to take up the post as State Secretary for Labour in the Swedish Government.

In 1994 he was appointed Director General and Chairman of the Board of Sida, a post he held for 9 years. He left Sida to become the Swedish Ambassador to Kenya, with accreditation to the Seychelles, Comoros, Somalia, Burundi and Rwanda. Supporting Rwanda after the genocide and assisting Somalia in its effort to move away from conflict, were the main challenges in that period.

Goransson was the Permanent Representative to UNEP and UN-Habitat and the President of the Governing Council of UN-Habitat. After leaving Kenya he served for two years as a Special Advisor to the President of the African Development Bank. He is a member of the Advisory Board of UNITAR.


of Europe, Eurasia, Russia, and Turkey. He also worked closely on public diplomacy issues and was a member of the Policy Planning team.

Prior to his appointment as Special Envoy, Booth served as U.S. Ambassador to the Federal Democratic Republic of Ethiopia, where he facilitated an expansion of regional security cooperation and created a regular dialogue on controversial issues of democratic governance and human rights. He served as Ambassador to the Republic of Zambia, where he focused on restraining the HIV/AIDS epidemic, expanding press freedom and fighting

corruption. As Ambassador to the Republic of Liberia, he played a crucial role in ensuring Liberia's post-conflict transitional government held internationally supervised elections on time and that all parties accepted the outcome. He also secured Liberian government agreement to a major international role in an anti-corruption program - the Government and Economic Management and Assistance Program (GEMAP) that facilitated economic investment and recovery. As a U.S. trade negotiator, he helped devise an agreement among major producers that avoided disruption of the aluminium market in the early 1990s.

In the U.S. State Department, Booth held positions as Director of the Office of Technical and Specialized Agencies in the Bureau of International Organization Affairs, Director of the Office of West African Affairs and Deputy Director of the Office of Southern African Affairs. He served as Counsellor for Economic Affairs in Greece and as Division Chief for Developed Country Bilateral Trade Affairs in the Bureau of Economic and Business Affairs. After retiring from the U.S. Foreign Service in 2017, Ambassador Booth worked as a consultant to The Carter Center's Sudan and U.S.-China-Africa Cooperation programs. Following his recall as Special Envoy for Sudan, he is co-chairing the Woodrow Wilson Center's "Sudan's Working Group" and volunteers regularly with Habitat for Humanity and Rebuilding Together.


### Douglas Scott PROUDFOOT - Canada

### Elisabeth PAPE – Germany

Elisabeth Pape spent almost 30 years as a European Civil Servant, working at the nexus of development, economics, and foreign relations. Her duty stations alternated between Brussels, Africa, and the US. Along the way, she gained a network of trusted interlocutors around the globe. As former EU Ambassador to Namibia, she is familiar with high-level political dialogues. She is equally conversant with technical discussions with government officials at all levels as well as multilateral organisations on governance and economic reform programs.

In terms of institutional collaboration, Pape brings—apart from her European Union DNA—a background of working in sync with the World Bank (including two years in the office of the Chief Economist and Sector Manager for Africa), the IMF, the United Nations (her very last post was in the EU Representation in New York), the OECD, the International Network on Conflict and Fragility (INCAF), the OACPS (79 countries closely linked to the EU through the Lomé/Cotonou/Samoa Agreements), and the g7+, a group of 20 self-declared fragile countries.

Convinced that conflict is the ultimate barrier to achieving the Sustainable Development Goals, Pape enhanced her skills in conflict prevention and resolution. She completed an M.A. in Mediation and Conflict Management at the Viadrina Europa University in Frankfurt/Oder in 2013. Furthermore, she was trained in Peace Mediation in the EU context as well as in Gender in Peace Operations at the International Peace Support Training Centre in Kenya. Pape was also part of the first cohort of people trained on Recovery and Peace Building Assessments (RPBAs) in Addis Ababa, a joint initiative by the EU, the World Bank, and the UN. The three institutions jointly organised the World Reconstruction Conference 3 with 800 participants in Brussels in 2017, for which she took the lead on the EU side. She helped shape the European Union's Integrated Approach to fragility and resilience.

Pape has furthermore set up training courses, including online training on conflict sensitivity and conflict analysis. She frequently served as a resource, including at the NATO training on the Integrated Approach. While posted in New York, she covered, among other dossiers, the Humanitarian-Development-Peace (HDP) Nexus and joined the UN Peacebuilding Fund on a mission to the Central African Republic.

When she retired in September 2021, she moved from New York to Berlin. With the intention to give back to society, she got involved in the modern hospice movement and trained as an end-of-life companion. She also joined the Board of the Alumni Association of Viadrina Mediation Students (2022–2024) and recently became a Board Member of the Association of European Union Retirees.

Frederic Gateretse-Ngoga is a Burundian diplomat who is currently the senior advisor on international partnerships, the AU Border Program, and regional security mechanisms in the office of the Commissioner for Political Affairs and Peace and Security of the African Union Commission. In 2014 he was appointed as Ambassador Extraordinary and Plenipotentiary of the Republic of Burundi.

Before joining the African Union Mission to Somalia, Ambassador Ngoga was a regional manager for Africa with iJET Intelligence Risks, a US based provider of operational risk management solutions. He also worked as an Africa security

analyst for TranSecur and for Solutions for Progress Inc in Philadelphia, where he assisted in the research for the book *Raise the Floor – Wages and Policies That Work for All of Us*, by Holly Sklar and Laryssa Mykyta.

From 2009 to 2014 he served as a senior officer with the African Union Mission to Somalia (AMISOM) where he assisted operational teams from the Military, Civilian and Police components to provide support on Counter Terrorism and in the planning of military operations in line with AMISOM's mandate. From 2014 to 2021 he was the head of the conflict prevention and early warning division in the Peace and Security Department. The Division included the Continental Early Warning System, the Panel of the Wise and the AU Border Program. He worked to enhance the AU's ability to do Early Warning, assisted Member States to address structural vulnerabilities. He worked on better equipping preventive diplomats and assisted to strengthen national capabilities to respond to prevent violent conflicts. During his tenure a strong emphasis was put on building stronger partnerships with regional and sub-regional organisations in the area of conflict prevention.

With a strong interest in Institutional capacity, governance, regional and international partnerships, counter terrorism, climate peace and security, he has also worked on the crises in Libya, Sahel, Central African Republic and the Horn of Africa. In 2019 he was part of the secretariat that worked on the CAR Global Agreement for Peace and National Reconciliation signed on 6 February in Khartoum, Sudan. He is a board member of the UNDP Preventing and Responding to Violent Extremism in Africa project, board Member of UNDP Africa Borderlands Centre (ABC), member of the steering Committee of the Bilalo Byetu "our bridges" project of the UNDP/ElMan Center. He is also a board Member of Med-or-Foundation and a member of the International Commission on Inclusive Peace.

She also served as High Commissioner of Jamaica to the United Kingdom and concurrently non-resident Ambassador to Portugal, Norway, Finland, Denmark, Sweden and Spain. Gene Cretz served as a Peace Corps Volunteer in Kabul, Afghanistan (1975-77) before joining the Foreign Service in March 1981. On July 11, 2007, President Bush nominated Cretz to be the United States Ambassador to Libya and he was confirmed by the Senate on November 20, 2008. After serving in Tripoli (2008-2012), Cretz served as Ambassador to Ghana (2012-2015). From August 2015-December 2019, he was the representative of the Director General of the Multinational Force and Observers (MFO) in Tel Aviv. He currently serves as Senior Advisor for social impact programs for Hamilton Advisors.

### Giovanna DI COLA - Italy

A citizen of Italy, Giovanni Di Cola studied in Rome and Paris, earning a fouryear bachelor's degree in international relations from the University of Rome La Sapienza, a master's degree (DEA) from Sciences Po Paris in Soviet Studies, and a PhD in Development Economics from the University of Paris X (Ouest).

Giovanni has a wide experience within the United Nations System, having served in four UN agencies (UNESCO, UNFPA, UNICEF, and ILO) with assignments at the UN Staff College and at the UN Secretariat under Kofi Annan as UNSG. His field experience started in Senegal at the UNESCO-BREDA regional office for sub-Saharan Africa as Assistant to the Regional

Director (1983-1985), under a period of important changes in the national execution technical cooperation and with Makhtar M'Bow as UNESCO Director General. He became Consultant for UNFPA in West Africa (Senegal) dealing with a book on Population Education co-edited by the most respected demographers and political figures of West Africa during 9 months between 1985 and 1986. Between 1986 and 1988 he was then appointed as UNICEF Communication and Information officer in Niamey (Niger) dealing with emergency programme, negotiating nutrition and vaccination programmes with religious and civil authorities alike. As Associate Expert at the ILO HQS, between 1988 and 1990, in Geneva he managed labour intensive programmes, working closely with UNDP and WFP, in lusophone countries of Africa.

Giovanni returned to Dakar as ILO Programming Officer covering operational activities of 11 countries of West Africa between 1990 and 1994. He strengthened ties with social partners and focused on a country that underwent civil war(s) and would become the subject of his thesis related to Guinea Bissau (macro policies and poverty reduction strategies). He was then transferred to the ILO Regional Office for Latin America and the Caribbean in Lima (Peru) as Chief regional programming from 1994 to 1998 during the "toma" of the Japanese Embassy under President Fujimori regime. From 1998 to 2001 he was senior relations officer at the ILO HQS dealing with the Governing Body reports on technical cooperation, relations with Donors (Italy, Spain. Portugal and Greece) and desk officer to the regional office for Middle East. As Desk Officer of the ILO Regional Office for Middle East, he would take part in three successive ILO Director General missions to the 'Arab Occupied Territories' reporting back to the International Labour Conference, between 2003 and 2005. The mission met with both Israelis and Palestinians officials including former President of the PLO Yasser Arafat, Prime Minister Mahmoud Abbas, and Mohamed Staye, Head of the Planning Institute of the NPA and the Prime Minister. The report of 2004, prepared under the most tense period of the second Intifada provided a basis for dialogues and peace talks over working conditions and employment of Palestinian workers.

In 2001 Giovanni was also appointed UNDAF Focal Point fostering cooperation and leadership of the UNCTs to implement the UN reform. He fulfilled missions to Tajikistan, Irak, Eritrea (crisis and humanitarian situations) and Albania, Cape Verde, Cameroun, Senegal, and Peru for development cooperation frameworks. He underwent a training for mediation and conflict resolution which helped setting up an office of the Ombudsman at the ILO and served as facilitator since. For his role as negotiator within the UNDAF and with several high-level missions undertaken at the request of the UN Staff College.

Giovanni dealt for the UN Secretariat in Ney York to youth leaderships, as he worked closely with the UN Special Adviser Office on sport, development and peace, by former President of the Swiss Confederation. In 2001 he led a negotiation with the Italian Government that resulted in a major (13 million USD) interagency and interregional programme on local economic development in Central America, the Balkans and Southern Africa. He contributed to establish a network of 150 universities, on local economic development, and various masters on: (a) labour diplomacy with West Indies University (Trinidad and Tobago), (b) skills development through sport with Kennesaw State University (USA) and Lille University (France), (c) disaster management and prevention with Ancona (Italy) and Sri Lanka Universities, and (d) industrial and labour relations with Cornell University (USA). Between 2003 and 2009 as ILO focal point for sport, development and peace, an initiative by the late UNSG Kofi Annan entrusted to a former President of the Swiss Confederation Mr Adolf Ogi, he travelled the world and connected with UNRCs and high levels national stakeholders throughout.

In 2009 he was appointed Deputy Director of the ILO Decent Work Team and Office for the Caribbean and in 2013 he was appointed Director of the same Office until 2015. In the ILO Caribbean Office, he established a permanent Labour Minister's Forum of 22 Caribbean countries and Territories. He reinforced the partnerships with the Caribbean region (CARICOM), with the Association of Caribbean States (ACS) and with the Small Islands Developing States (SIDS). He was ILO representative to the Samoa UN Summit on Small Islands Developing States (SIDS) in September 2014 and to the ACS Head of States Summit in Merida (Mexico) in April 2014. In 2015, he was appointed Special Adviser to the Deputy Director General for Field Operations and Partnerships at the ILO in Geneva dealing with UN reform, Sustainable Development Goals, global partnerships, and Mega Sporting Events and human and labour rights. He was also attached to the Commission of the ILC on The Future of Work adopted in June 2019. In 2020, he was ILO lead expert of the Global Forum on Decent Work in the world of sport, which adopted the Points of Consensus setting the ILO agenda in the world of sport.

Since 2023, Giovanni is CEO of a consultancy company using skills to achieve sustainability and providing, advice to national policies and programmes on labour, employment and international labour standards, using dialogues to achieve policy outcomes. He is also consulting on humanitarian/crisis and business resilience. He lectures on the importance of geopolitics in today's business frameworks and sustainability including sport and human rights.

# **Huseyin BOTSALI** – Turkey

Ambassador Botsali has held a variety of senior diplomatic positions, including his last few as Ambassador to Cairo (2009-2013), Turkey's Permanent Representative to UNESCO in Paris in (2014-2016), Vice President of Turkish National Commission for UNESCO and Advisor to the MFA (2016-2018), OIC Secretary General's Envoy and Permanent Representative of the OIC in Afghanistan (2018-2020).

First appointed to Afghanistan as First Secretary of the Turkish Embassy in Kabul (1988-1991), Botsali later joined the UN International Staff field team as Senior Political Affairs Officer at the United Nations Good Offices Mission in Afghanistan & Pakistan (UNGOMAP, 1991- 1992). He was designated as

Secretary General's liaison officer with mujahedeen leaders and the Interim Government in Peshawar/Pakistan and later also with GOA-in Kabul, contributing to peace-building talks; subsequently he served as the Head of the Office of the UN Secretary General for Afghanistan and Pakistan (OSGAP) in Kabul (1992-93).

Mr. Botsali was appointed by the MFA Turkey as Deputy Secretary General of the Economic Cooperation Organisation in Tehran, enlarged to include Afghanistan and the CARs (Azerbaijan, Kazakhstan, Kirghyzia, Tajikistan, Turkmenistan & Uzbekistan, 1993-1996). During this period, he presided over ECO's Transportation, Trade and Customs, Energy, Health, Environment, Culture and Narcotics Control Committees. He also attended 49th and 50th UN General Assembly sessions, IBRD, IMF, UNCTAD General Assembly sessions, as ECO Observer, and led the ECO Delegation to the EU Commission in in Brussels. He returned to Ankara as Head of Department for Middle East and Gulf Affairs, MFA (1996-1998), then was appointed Counsellor at the Turkish Embassy in Washington D.C. (1998-2001).

In 2001 he became Turkey's Consul General in Komotini, Greece and returned to Ankara to head the Middle East and Gulf Affairs Department for the second time (2004-2005). He was then promoted to Consul General of First Grade to reactivate the Turkish Consulate General in Mosul, Iraq. Throughout his stay in Iraq, Ambassador Botsali organised relief and humanitarian aid operations, including over 20 medical-emergency evacuations, saving hundreds of victims of terrorist attacks targeting civilian communities in Mosul, Telafar, Arbil, Kirkuk, and Suleimaniyah.

Following his retirement from Turkish Foreign Service and OIC, Ambassador Botsali has been invited as speaker or panellist to a number of peace-building and conflict-prevention fora. Recently he joined a private Turkish corporate entrepreneurship, specialised in infrastructure and renewable energy investments, as Government Relations coordinator. Ambassador Botsali speaks English and French. He also communicates in German, Portuguese, Dari and Persian - only spoken.

Janan Mosazai was a researcher and producer with BBC World TV for a year before and after the tumultuous events that followed the attacks of 11 September 2001 in the U.S. in both Pakistan and Afghanistan (2001-2002). He also worked with the United Nations Assistance Mission in Afghanistan (UNAMA) focusing mainly on political affairs and human rights issues (2002-2005).

Ambassador Mosazai studied medicine at Kabul Medical University and international relations at the American University of Central Asia in Bishkek, Kyrgyzstan. He holds a Master of Journalism (MJ) degree from the School of Journalism and Communication at Carleton University in Ottawa, Canada. He is fluent in Pashto, Dari and English, and has basic to moderate knowledge of Urdu, Russian, French, Arabic, and German.



From September 2015 to August 2019, he was European Union Ambassador to the Islamic Republic of Pakistan. From September 2019 to his retirement in April 2022 he was advising the Director of the Integrated Approach for Security and Peace directorate in the European External Action Service. In this capacity, he went to Afghanistan Doha talks to meet the two Afghan negotiating teams in March 2021.

Since May 2022, he lives in Kabul supporting inter alia Europe and US-based advocacy organisations working on the roots causes of the current economic / humanitarian crisis and organisations involved in peace-building.

Cautain holds a Master in Development Management from the London School of Economics (2000), and a Doctorate in Veterinary Medicine (1983).

As foreign minister, he led several rounds of the Bhutan-Nepal talks in the search for a dignified and durable solution to the protracted problem of the

displaced people (over 100,000) in the refugee camps in Nepal. In the process, he developed a cooperative spirit between the two countries which had otherwise become mutually suspicious and hostile. Ultimately, he initiated a discreet dialogue with several western nations including the USA, which received and resettled all the concerned people within a few years. He also led the Bhutanese delegation at the highly sensitive Bhutan-China border negotiations at which the first-ever bilateral agreement with China was signed. In it, China, for the first time, acknowledged and affirms its respect for Bhutan's sovereignty.

One of Thinley's diplomatic successes was to broaden and elevate Bhutan's hitherto donor-recipient bilateral relationship with several European countries as well as the EU by engaging in periodical policy dialogue on a

range of topics of mutual concern including international security. This significantly enhanced Bhutan's image and role in the international community.

As a member of the Club de Madrid (CdM), Mr. Thinley co-led two delegations to Myanmar as a part of the Club's project to promote peaceful reconciliation among various parties in conflict and to promote democracy. His last visit was just before the first democratic elections that led to the establishment of Aung San Suu Kyi's full-term government. As a member of the Asian Peace and Reconciliation Council (APRC), he has and will continue to encourage the ASEAN nations to continue with prevailing bilateral cooperative engagements with China and to explore new areas of cooperation while pursuing diplomatic options toward mutually beneficial and durable solutions.

#### João HONWANA – Mozambique

João Honwana is an independent consultant on Peace and Security, Conflict Resolution, International Mediation and Peacebuilding. Prior to joining the UN, Honwana had an active career within Mozambique's security forces and politics. At independence, he was seconded to the police force as Provincial Police Commander in Zambézia (1975-1976); he was later trained as a Fighter Pilot and Airforce Tactical Commander in the former Soviet Union (1976-1979, 1982-1983). Honwana was the Commander of the Air Force and Member of Parliament in his home country Mozambique (1986-1993). After retiring from the Air Force in 1993, Honwana served as Senior Adviser on Regional Politics & Security to the Minister of Foreign Affairs of Mozambique.

Honwana is an accomplished researcher and analyst. He is a graduate of the Royal College of Defence Studies (RCDS/1990), UK, and holds a Masters' Degree in War Studies from Kings College, London (1992). He has written extensively on civil-military relations, preventive diplomacy, peacebuilding, regional security, and political mediation. He was a Senior Researcher and Project Coordinator at the Centre for Conflict Resolution at the University of Cape Town in South Africa (1993-2000), where he contributed to the design and delivery of Conflict Resolution and Mediation Courses to senior officials in the SADC countries and engaged in mediation exercises in Burundi, Lesotho, and Zimbabwe.

### Maged ABDELAZIZ - Egypt

On peace and security, he was a member of the Egyptian delegation to the Security Council (1984 & 1985); the Political Coordinator of the delegation in the Security Council for a second term (1996 & 1997). As Vice President of the United Nations General Assembly (2008-2009), he represented Egypt in all NPT Review Conferences (1980-2015). Abdelaziz has chaired the Coordinating Bureau of the Non-Aligned Movement in New York (2009-2012), the UN Inter-Agency Taskforce in support of African development, peace & security, and head of the Egyptian delegation to NPT Rev Con (2010). He contributed extensively in shaping and reforming the Peace & Security Architectures of the UN and the AU, and in crafting the joint UN-AU framework agreements for peace, security & development in many parts of Africa.

On human rights and humanitarian issues, he took part in the establishment of the Human Rights Council, Peace Building Commission, UN-Women, UN Youth office, and the AU-APRM. He also played a leading role in the development of new concepts such as Responsibility to Protect (R2P) and Human Security, and contributed, as a lawyer, to the codification of many international law norms, treaties and conventions. Ambassador Abdelaziz graduated from Ain Shams University School of Law in 1973.

### Nina LAHOUD - United States of America

Nina Lahoud left the law firm of Shearman & Sterling in 1983 to join the UN peacekeeping force in Lebanon (UNIFIL) as the first female Legal Adviser appointed to a peacekeeping mission. Her UN career spanned over 33 years, during which she handled diverse legal, rule of law, peacekeeping, peacebuilding, development, human rights, and gender justice matters while serving in various offices at UN Headquarters, a UN Regional Commission, and six UN peacekeeping missions in Lebanon, Namibia, Cambodia, Croatia, Kosovo, and East Timor.

Before moving to the Department of Peacekeeping Operations (DPKO) in 1997, she spent a decade in the UN Office of Legal Affairs. During her two decades in DPKO, she took on wide-ranging roles, including as Principal Officer to the Assistant Secretary-General for Peacekeeping. In this capacity, she developed proposals for strengthening the gender architecture of UN peacekeeping missions and the integration of gender expertise in mission planning and assessment processes. As a member of the UN Inter-Agency Standing Committee on Women, Peace, and Security, she also shared these proposals with the 2015 High-Level Independent Panel on Peace Operations and the Independent Global Study on the Implementation of UN Security Council Resolution (UNSC) 1325 on Women, Peace, and Security.

Earlier, she served as DPKO's Deputy Director of the Asia and Middle East Division, Special Assistant to the Under-Secretary-General for Peacekeeping Operations, and Head of the Rule of Law Project. She spearheaded the Secretary-General's Executive Committee Task Force for the Development of Comprehensive Rule of Law Strategies for Peace Operations, and served as a member and secretariat head. She also held positions with other UN entities, including as Principal Officer to the Secretary-General's Special Adviser on Iraq, Gender Adviser to the Under-Secretary-General of the UN Economic and Social Commission for Asia and the Pacific, and Special Peace, Security, and Rule of Law Adviser to the Executive Director of the UN Development Fund for Women (UNIFEM). On UNIFEM's behalf, she led the organization of two international conferences on gender justice in post-conflict situations, with the ground-breaking reports submitted to the UN Security Council.

Currently, Ms. Lahoud is on the Board of the International Legal Assistance Consortium (ILAC), the Global Leadership Council of Seeds of Peace, and the Advisory Board of PassBlue, and is a member of other professional legal and foreign policy organizations. She is actively involved in various legal, social justice, and gender initiatives, and was appointed by the Secretary-General's Office to the Advisory Group to the UN High-Level Task Force on Financing for Gender Equality. Advocating for gender justice, she published, in advance of the 20th anniversary of UNSC Resolution 1325, an article which offered recommendations for accelerating its implementation and its successor resolutions (see JOUP 24 (2020) 1-52).

She also participated as a speaker and moderator at the International Conference for Women, Peace and Security held in September 2022 in Abu Dhabi. Nina Lahoud holds a B.A. from Harvard University, and a Juris Doctorate and a Certificate in Islamic Law from the University of Pennsylvania Law School.

### Paul DZIATKOWIEC – Australia

Paul Dziatkowiec was an Australian diplomat before transitioning to conflict mediation, where he has held various senior roles over the last 12 years. He is the Director of Mediation and Peace Support at the Geneva Centre for Security Policy (GCSP), where he has launched and facilitates discreet dialogues in various regions, including the Caucasus, Middle East, Eastern Europe, Arctic, and Asia, as well as the US-China context.

Previously at the Centre for Humanitarian Dialogue (HD), a leading conflict mediation organisation, Dziatkowiec managed numerous confidential dialogue tracks focused on Ukraine and security in Europe, including in the Ukraine-

Russia and West-Russia context. In addition to his deployment to Ukraine, at HD he was involved in mediation in other conflict settings including Myanmar, Nigeria and Thailand. Also at HD, for five years he managed the Oslo Forum, the pre-eminent global forum for mediators and peace process actors.

In the Australian diplomatic service, Dziatkowiec served in Africa, the Middle East, and the Asia-Pacific. He was a peace monitor in Bougainville, Papua New Guinea after the civil conflict, where he was engaged in investigating ceasefire violations, awareness-raising of the peace agreement, weapons disposal and inter-communal reconciliation. For his services he received the Australian Service Medal.

Later Dziatkowiec served in the Middle East, where he was posted in Tel Aviv and periodically acted as Australia's Representative to the Palestinian Authority in Ramallah. Subsequently he became Australia's Deputy Ambassador in Nairobi, where from age 30 he regularly acted as Ambassador to Kenya and other countries of accreditation (including Somalia, South Sudan, Rwanda, Burundi, and Uganda) cumulatively for around a year – one of the youngest to serve with that rank.

In other roles in the diplomatic service Dziatkowiec engaged in multilateral negotiations at the United Nations in New York, Geneva and Nairobi, where he was Australia's Deputy Permanent Representative. He has published on conflict and mediation in the context of Africa, Middle East, Arctic, and US-China relations, and delivered guest lectures on these subjects in various countries including China, Oman, Ukraine, Japan, Georgia and Liberia. He also advises or provides mediation support to other organisations engaged in peacemaking, including the Inter-Parliamentary Union.

### Paul Adesola EGUNSOLA – Nigeria

Recently retired as Chief of Staff (COS) for the United Nations Mission in South Sudan (UNMISS) and Liberia (UNMIL), Egunsola holds over 43 years' experience in the field of diplomacy and international relations.

While in the Foreign Service, Egunsola served on the Nigerian delegation to the UN the Security Council, focusing on African security challenges, including but not limited to the Rwandan Genocide, and Somali and Liberian civil wars. As COS in UNMIL and UNMISS, he served as the chief liaison to the respective host governments and supported the establishment of high-level platforms to facilitate space for political engagement, negotiation, diffusing

tensions, and ensuring effective implementation of the Missions' mandates. The High-level Forum in South Sudan, which remains active to date, has served as a critical mechanism to ensure freedom of movement and safety of UN goods and personnel.

Both in the Nigerian Foreign Service, and during his tenure in the UN, Egunsola worked closely with and advised Nigerian Ambassadors and Special Representatives of the UN Secretary-General (SRSG), on strategic and operational initiatives – ensuring the effective implementation of strategic priorities. For example, as the longest-serving Principal, he reinforced and advised four SRSGs on strategic and operational matters. This included

establishing and overseeing specialized organs that facilitate executive direction and streamline decision-making along policy and operational lines.

Furthermore, having served with the United Nations peace operations in Kosovo, Liberia, and South Sudan, Egunsola has significant experience in crisis management- preventing, managing, responding to, and mitigating multi-dimensional crises. As Chief of Staff in South Sudan, he assisted successive SRSGs to manage a mission of over 22,000 personnel including military, police and civilian staff. Egunsola oversaw the strategic and operational response to the 2013 and 2016 outbreak of fighting in Juba, focusing on staff safety and security and ensuring continuity of mission's operations. Throughout the period, he reinforced integrated crisis management, and ensured processes were in place to enhance situational awareness and early warning mechanisms for the Mission.

Additionally, Egunsola oversaw the management of Protection of Civilian sites, responsible for providing physical protection for over 200,000 civilians during the war. With over 10 per cent of the displaced population in the country directly under the protection of the UNMISS, the office provided the strategic guidance to HoFOs to enhance the protection of displaced persons and developed frameworks and mechanisms to ensure an integrated and coordinated approach to camp management. Here, Egunsola worked closely with humanitarian and related agencies in finding sustainable solutions to the civilians in the UNMISS POC sites, four of which the Mission successfully redesignated to regular IDP camps.

### Renier NIJSKENS - Belgium

Renier Nijskens started his diplomatic career in 1974 and held multiple positions until his retirement in 2019. After junior assignments to Iraq, the then Zaïre, Kuwait, Tunisia, Canada, he was appointed Ambassador to Niger and Burkina Faso in 1987, to Kenya, Uganda, Seychelles and the Comoros in 1994, to the Republic of Korea in 1998, to the Democratic Republic of Congo in 2000, and to the Federal Republic of Germany in 2011.

In between those missions, Nijskens headed the Ministry of Foreign Affairs, the Department of Middle East and North Africa (1990 to 1994), the Asia and Far East Department (2007 to 2009), and the Africa Department (2009 to 2011).

He took a sabbatical leave in 2004 to become the Resident Representative in Johannesburg of the Netherlands Institute for Multiparty Democracy (NIMD), covering the different NIMD African programs in support of multiparty democracy (2004-2007). After his career was extended in 2014 to become Inspector General of the Belgian Diplomatic and Consular Missions (2014-2016), he accepted a final assignment as Special Envoy for the Great Lakes Region (October 2016- September 2019).

During his Headquarters assignments, Nijskens played key roles as Belgium assumed major international responsibilities: during the country's membership of the UN Security Council in 1991–1992 and 2007–2008, as well as 2019–2020 (in the latter period addressing the Great Lakes crisis); as a member of the European Troika and European Chair of the EU Middle East Working Group during the Oslo peace process (1993–1994); as part of the EU Presidency of ASEM (Beijing, October 2008); and as Chair of the EU Africa Working Group and participant in the 3rd Africa-EU Summit during Belgium's EU Presidency in 2010 (Tripoli, November 2010).

Nijskens' stronger involvements included proactive support to the Middle East Peace process initiated through the Oslo negotiations, and initiatives to help facilitate its implementation, a.o. through a strong multilateral program. As Ambassador of Belgium to the Democratic Republic of Congo (2000-2004) Nijskens took a proactive role in stimulating the intensive negotiations among all stakeholders in Congo to end the rebellions and avoid balkanization of the DRC, leading to the Sun City accords and including the innovative creation of the 'Comité International pour l' Appui à la Transition' (CIAT), a diplomatic tool which proved crucial to avoid a backslide of the fragile transitional coalition (2002 to the elections of 2006). He also handled with the family, the delicate postcolonial issue of the assassination of Patrice Lumumba in the wake of a Belgian parliamentary commission on this matter. As Regional Director for Africa of the Netherlands Institute for Multiparty Democracy (2004-2007), Nijskens developed several African national Centers for Multiparty Dialogue and elaborated a regional program to help exchange and share best practices. As Special Envoy for the Great Lakes (2016-2019), Nijskens contributed actively to building a regional African and International coalition to help bar President Kabila from overstaying his last constitutional term to allow the people of the DRC to express their free electoral choice. Active support was also given to the mediation initiatives of the Finnish CMI in trying to depolarize the political situation in Burundi.

Although his appointments were all formally confined to the bilateral level, Nijskens was only able to succeed by involving altogether the numerous perspectives that multilateralism also offered, sometimes by creating synergies, sometimes through bilateral phases of support, as well as civil society, wherever possible.

## Riyad INSANALLY - Guyana

Riyad Insanally retired as Guyana's Eighth Ambassador to the United States and Fourth Permanent Representative to the Organization of American States (OAS) in June 2021, after assuming the post in September 2016. A career diplomat for 31 years, he specialised in multilateral diplomacy, regional integration issues and Latin America-Caribbean relations. Prior to his last appointment, he was the OAS Representative in Trinidad and Tobago

(2008-2016); Adviser to the OAS Assistant Secretary General, in Washington, DC (2006-2008); Senior Trade Adviser at the Guyana High Commission and Commercial Representative of the Guyana Sugar Corporation, in London, representing Guyana's sugar interests in Europe (2004-2006); Political Adviser to the first two Secretaries General of the Association of Caribbean States in Port of Spain, Trinidad (1997-2003); and a Senior Foreign Service Officer in the Ministry of Foreign Affairs of Guyana (1990-1997), where he served, inter alia, as Deputy Director for Multilateral and Global Affairs, Head of the CARICOM Unit and first National Liaison Officer to the OAS. He was also a Lecturer in the Department of Modern Languages, at the University of Guyana, from 1981 to 1984.

He is currently a non-resident Senior Fellow at the Caribbean Initiative of the Atlantic Council's Adrienne Arsht Center for Latin America, a Fellow with the Caribbean Policy Consortium, and the Senior Caribbean Advisor at Transnational Strategy Group in Washington, DC. He is also an Associate of the University of Guyana Foundation; an inaugural member of the Global Advisory Council of The Presidential Precinct in Charlottesville, Virginia; and an Honorary Associate Fellow of the Centre for Caribbean Studies at the University of Warwick, UK.

He studied Modern Languages and Latin American Studies, and holds MA and MPhil degrees from the University of Cambridge and a PhD from Harvard University. He is fluent in English and Spanish, and proficient in French.

#### Robert ROGER NGANGUE - Cameroon

Mr. Robert Roger Ngangue was a human rights activist in Cameroon from 1993 to 2000. During this period, he coordinated the Support Program for the Local Development of Indigenous Bagyeli Peoples in Cameroon. The program was within the framework of the Cameroonian NGO Planet Survey, of which Robert Ngangue is the Founding President and Chairman of the Board of Directors. This program led to the enrolment of over 500 pygmies in primary and secondary schools, the issuance of over 1,000 birth certificates to the pygmies, and the empowerment of 300 women and young people from this group through the marketing of forest products and their active participation in global governance efforts to protect and promote the rights of indigenous

From 1997 to 2000, Mr. Ngangue represented the International Prison Observatory (IOP) in Cameroon as Secretary General of the NGO's Cameroon Section. He was responsible for the institutional, strategic and operational development of the IOP in Cameroon. During this time, membership rose from 10 to 500 members,

including some 450 volunteers deployed around Cameroonian prisons to signal early warnings about the violations of prisoners' rights. Mr Ngangue has implemented a program to provide legal and judicial assistance for prisoners, funded by the European Union Delegation to Cameroon. The program led to the decongestion of the prisons in Yaoundé, Mfou, Akonolinga and Mbalmayo, with over 1,000 detainees tried, sentenced or released. Over the same period, he visited almost all Cameroonian prisons to monitor the situation of people in detention and drafted an annual report on conditions of detention which was forwarded to the government authorities in charge of prisons. He also presented the report to the media to mobilize public opinion around the issue of obsolete prisons in Cameroon, and to encourage corrective measures in the functioning of the Cameroon penitentiary institution. These efforts earned him a position on the Interministerial Committee for the Promotion of Democracy and Human Rights in Cameroon, and a grant from the Cameroon High Commission in 1998 for the publication of an essay entitled ABC des droits des personnes détenues au Cameroun which means ABC of prisoners' rights in Cameroon.

Since 2000, Mr. Ngangue has served in the UN Department of Peacekeeping Operations. He is a seasoned peace expert with nearly 25 years of specific experience in international conflict management, supporting peace processes and local conflict resolution to overcome tensions, crises and political disputes in a non-violent and sustainable manner. He has numerous achievements in the fields of designing and implementing peace processes, facilitating and supporting political and community dialogues, peace talks, mediation, ceasefire negotiations with armed groups, ceasefire monitoring, preventive diplomacy and reconciliation at national, sub-national and local levels, notably in Kosovo, DR Congo, Côte d'Ivoire and the Central African Republic. He is a PhD candidate in mediation and conflict resolution, holds a master's degree in Conflictology, and a diploma as a certified professional mediator, accredited by the International Institute of Mediators. He is a member of several international networks in the field of mediation and dialogue facilitation. Mr. Ngangue has taken an early retirement from the UN and plans to use his expertise and passion for mediation and preventive diplomacy to promote less conflict-ridden societies and humanity on the African continent. This will be achieved through his NGO Ombudsperson and Mediation Initiative (OMI), which he founded in October 2024.



Roeland van de Geer, a retired diplomat of the European Union and the Netherlands government, is chairman and member of the boards of a range of NGOs active on the African continent in the fields of governance, mediation and capacity building in conservation and agriculture. In the period 1978 - 1994, Mr. van de Geer was a staff member of the Free University, Amsterdam and of the Ministry of Foreign Affairs in the Netherlands. In 1994, he was appointed Dutch ambassador to Mozambique, in 1998 Western Hemisphere Director at the Ministry of Foreign Affairs and in 2002 Africa Director. He then served as Dutch ambassador to Afghanistan and was appointed as Special Representative of the EU for the African Great Lakes Region in 2007. In 2011, he became

Ambassador of the EU to South Africa and in 2015 Ambassador of the EU to Tanzania and the East African Community. In 2018 and 2019 he served as the Coordinator of the European Union for the African Great Lakes Region.



#### Sheila CAMERER – South Africa

Sheila Camerer is a former Member of Parliament and Ambassador. She was elected to Parliament in 1987 and served as an MP, representing constituencies in Johannesburg, for 22 years until 2009 President Thabo Mbeki appointed her as Ambassador to Bulgaria 2009-2013.

She took part in South Africa's constitutional negotiations from the start in 1991 to 1996 when the final constitution was adopted. She served initially on the multi-party media committee and then as a member of Working Group 2 of CODESA. At the beginning of 1993 she was appointed Deputy Minister of Justice by President F W De Klerk in which capacity she chaired the Ad Hoc

Committee of the Negotiating Council of the Multi-Party talks at the World Trade Centre on the Bill of Rights. Subsequently she was a negotiator on the Bill of Rights in the Constitutional Assembly of the new democratic Parliament and served as Deputy Minister of Justice in President Nelson Mandela's Government of National Unity.

She was elected as a National Party MP but in 1999/2000 she helped to found the Democratic Alliance (DA), now South Africa's largest opposition party and the Official Opposition in Parliament, and was its first Parliamentary caucus chair. As a DA MP she served as Party spokesperson on Justice and Constitutional Development. She served on various other Parliamentary portfolio committees including International Relations and the Joint Committee on the Improvement of the Quality of Life and Status of Women.

Sheila Camerer is still a practising attorney and serves on the DA'S Federal Legal Commission. From 2015 to 2022 she chaired the Western Cape branch of the South African Institute of International Affairs (SAIIA) and is currently vice chair. In 2023 she was elected to the Executive Committee of the National Council of SAIIA.

Born and brought up in Cape Town where she resides today, she is a Patron of Cape Town City Ballet and chairs their endowment trust, is a member of the International Women Club and serves on other executive committees associated with the arts and community bodies.

## Stephanie WILLIAMS - United States of America

Stephanie Williams has extensive experience in international mediation, diplomacy, and security policy. With the United Nations, she served most recently as the Special Adviser to Secretary General on Libya (2021-2022), Acting Special Representative and Head of the United Nations Support Mission in Libya (UNSMIL) (2020-2021), and as Deputy Special Representative (Political) of UNSMIL (2018-2020). Williams led the United Nations' mediation that resulted in a nation-wide Libyan ceasefire agreement signed on October 23, 2020 and a political agreement reached on February 5, 2021 that produced Libya's first unity government in seven years.

Williams retired from the U.S. Foreign Service in 2018 with the rank of Minister-Counsellor after serving as Chargé d'Affaires a.i. for the U.S. Embassy to Libya based in Tunisia. She also served as Senior Adviser on Syria (2017-2018), Deputy Chief of Mission at the U.S. Mission in Iraq (2016-2017), in Jordan (2013-2015) and in Bahrain (2010-2013) in addition to tours in the United Arab Emirates, Kuwait and Pakistan. In Washington, she served in a variety of policy jobs, including as Director of Maghreb Affairs.

Williams graduated with honours from the University of Maryland in 1987 with a double degree in Economics and Government Relations. In 1989, she earned a Master's Degree in Arab Studies from Georgetown University's Center for Contemporary Arab Studies. She is a 'Distinguished Graduate' of the National War College, where she earned a Master's Degree in National Security Studies in 2008. Williams is fluent in Arabic, has authored a number of articles on Libya, Lebanon and non-state armed actors, and been a featured speaker in a variety of international fora. In addition to serving as a Senior Fellow at the SAIS-Johns Hopkins Foreign Policy Institute, she is a Non-

Resident Senior Fellow at the Brookings Institution's Center for Middle East Policy and a member of the American Academy of Diplomacy. In 2021, Williams was awarded the Commander's Cross of the Order of Merit of the Federal Republic of Germany for her work in Libya.

He is now President of the Board of Trustees of the Centre for Dialogue, Research and Cooperation (CDRC).

# **Thierry BECHET** – Belgium

Ambassador Bechet started his career as a national diplomat and joined the External Relations department of the European Commission in 1989 to deal with Middle East issues. In August 2021, he was appointed Chief of Protocol of the European Diplomatic Service in Brussels. Since retiring from the European civil service in August 2023, he has been dividing his time between international consulting, teaching, coaching of diplomatic service officers, and NGO work.

## Vladimir Zhagora – Belarus

A graduate of Minsk State Linguistic University (BA in Humanities, in 1972) and Belarusian State University (PhD in Political Philosophy, in 1980). Before joining the United Nations in 1988, Vladimir Zhagora taught for nine years Political Science and International Relations in various higher educational institutions in the city of Minsk, Belarus.

During more than 23 years at the United Nations Secretariat, Vladimir participated in the negotiations on the political settlements in South Africa, Somalia, between Eritrea and Ethiopia, in The Sudan, including Northern and Southern Sudan, in Darfur and in Eastern Sudan, as well as in Eastern DRC, Kenya, Northern Uganda and Zimbabwe. From 2010 till 2012, provided

substantive liaison and institutional support from the United Nations to the African Union High-Level Implementation Panel led by President Thabo Mbeki on the settlement in the Sudan. During mediation processes in Kenya, South Sudan, Darfur, Northern Uganda and Eastern DRC closely interacted with various regional mediation entities led by former Presidents Buyoya, Obasanjo, Mkapa, Chissano, Abubakar, as well as Dr Salim Ahmed Salim and Ambassadors Eliasson and Sahnoun. In 2008-2009 he was closely involved in the resolution of the crisis in Kenya by coordinating UN support to the AU Panel of Eminent Personalities in Kenya led by former Secretary-General Kofi Annan.

In March 2014, Vladimir was designated as the representative of the Department of Political Affairs in Ukraine. In 2015, he served as the Coordinator of the Security Council Group of Experts on South Sudan.

Linked to the above are his field deployments: in 1992-1994 with UNOMSA in South Africa; in 2002-2003 with UNMEE in Eritrea and Ethiopia; in 2004-2005 with UNAMIS/ UNMIS in the Sudan; in 2006-2007 in Uganda and in South Sudan; in 2008 in Zimbabwe; in 2008-2009 in Kenya; in 2010-2012 in Ethiopia; in 2014 in Ukraine.

From 2005 until his retirement in 2009, he served as a Mediation Focal Point for Africa at the Department of Political Affairs. Although retired, Vladimir participates in the activities of the Science for Peace Council (Canada) and supports the debates in the Political Discussion Group of the former UN staff members on the war in Ukraine.

### Won-Soo KIM - Republic of Korea

Mr. Kim Won-soo is the Rector of the Global Academy for Future Civilizations at the Kyung Hee University in Seoul, Korea. He is also the Chair of the International Advisory Board of the Taejae Future Consensus Institute in Seoul, Korea as well as the member of the Eminent Persons Group of the Comprehensive Nuclear Test Ban Treaty Organization (CTBTO) and the board member of the Ban Ki-moon Center for Global Citizens respectively based in Vienna, Austria.

Before that, he has diplomatic and policy experience of forty years which began in 1978 joining the Korean Foreign Ministry and then moving to the United

Nations in 2007 after successfully leading the campaign and transition team for the newly elected 8th Secretary-General in 2006. Over the next ten years, he served as a most senior official at the United Nations. He was the Under Secretary-General and High Representative for Disarmament Affairs from 2015 to 2017.

Prior to taking on this post, Mr. Kim worked as the Assistant Secretary-General and the Deputy Chef de Cabinet to the Secretary-General from 2007 to 2012, led the Change Implementation team from 2012 to 2013 and then served as the Secretary of the Chief Executives Board for Coordination (CEB). As Secretary of the CEB from 2013 to 2014, he was in charge of the system wide coordination of key multilateral policy issues relevant to all the executive heads of the United Nations (UN) system, including the Bretton Woods institutions. In these capacities, he played a catalytic role in ensuring more effective and coherent response to global and regional challenges to international peace and security, development as well as human rights and justice by promoting the unity of purpose and the culture of working together within the UN system.

As Special Adviser to the Secretary-General and subsequently as High Representative for Disarmament Affairs, Mr. Kim served as the link between the United Nations and partner international organisations involved in the global disarmament agenda. Throughout his tenure as a most senior official of the UN system at the political appointee level over a decade, he also focused on developing a multi-stakeholder partnership with international organisations and Member States, in close cooperation with the civil society and private sector including the industry and business as well as the scientific and academic communities.

Before joining the UN in 2007, he worked in the Office of the President of the Republic of Korea, serving as Secretary for International Security Affairs from 2000 to 2002 and as Secretary for Foreign Affairs and Trade from 2002 to 2003. He then served as Director-General for Policy Planning and Ambassador for Regional Security Cooperation in the Ministry of Foreign Affairs from 2004 to 2005, and in 2006 as Ambassador for UN issues and Special Adviser to the Foreign Minister. His diplomatic career also included overseas postings at the Republic of Korea embassies in Washington D.C., USA and New Delhi, India as well as the Korean Mission to the UN, New York, USA.

Mr. Kim holds a Bachelor of Law degree from Seoul National University, and a Master of Arts degree from the Paul H. Nitze School of Advanced International Studies (SAIS) at Johns Hopkins University, United States. In addition, he was a Visiting Fellow at Stanford University, United States, and did doctoral research in international law following the completion of a Master of Laws degree.
